The Mohua (Golden Bay) Blue Penguin Trust was formed to preserve, protect and enhance the population of Little Blue Penguins and their habitat.

In 2020 your Foundation gave a small grant to the Mohua Blue Penguin Trust to assist with the costs associated with the installation of road-signs in Mohua (Golden Bay) warning drivers of the possibility of Blue Penguins on the road.

Generous gift aids the safety of Little Blue Penguins

The generosity of Laura Papp, a Top of the South Community Foundation 'Living Giver', has enabled the purchase and installation of road-signs that will aid in the protection of the endangered Little Blue Penguin.

With multiple kororā nests straddling Abel Tasman Drive, penguins are regularly on the road at night with numerous deaths each year. This results in young kororā chicks dying as it takes two parents to nurture the offspring to the point of self-reliance (guarding the nest or gathering food).

Following assistance from the Top of the South Community Foundation, the Blue Penguin Trust has installed two active traffic management signs along Abel Tasman Drive, one at Pohara and one at Ligar Bay.

Diabetes New Zealand Nelson Youth Branch

The primary focus of the Nelson Youth Diabetes group is to create safe and positive community events for children and their families.

In 2020 the Top of the South Community Foundation made a grant that assisted in the purchase of My Identity medic alert style bracelets, which were then gifted to families who needed them.

Grant assists local youth with Diabetes

Generally diagnosed in childhood or early adolescence, Type1 Diabetes can pose significant challenges for young people and their families as they move to self-management for serious physical health risks, mental and emotional wellbeing stresses, financial pressures, and difficulty fitting 'condition management' around their lives.

The Top of the South Community Foundation grant offered an opportunity to purchase additional My Identity bracelets, which had the positive effect of lifting a huge weight off parents when they are not present with their child. Each bracelet has information unique to the child and can inform those around them how, or who to call, to manage their condition.

An exciting Pasifika Youth annual programme is generously supported by the Fa'avae Pasifika Fund, a Community Group Fund managed by Top of the South Community Foundation

In 2021 world-renowned adventure racer Nathan Fa'avae set up the Fa'avae Pasifika Fund, with the primary goal to carry on his parent's great community work and to ensure Pasifika youth in the Nelson Tasman region would be offered opportunities to grow and develop.

Annual funding offered to Whenua Iti Outdoors (WIO) by the Fa'avae Pasifika Fund has opened many new doorways and opportunities.

This has included the chance to strengthen the WIO relationship with the Pasifika community, co-design a series of events and camps, and link those to other events at WIO and beyond to ensure the impact continues beyond the first adventures.

The gift also offered leverage opportunities that enabled WIO to apply for further funds from other providers to further support the community, thus magnifying the impact of the initial gift.

Entity's Purpose or Mission

The mission of Top of the South Community Foundation is to inspire and enable generosity to benefit our local community forever. We encourage people to consider leaving a gift in their will during their lifetime to benefit the wider Nelson, Tasman and Marlborough regions. The capital remains intact, annual distributions are made from individual's endowment funds and the distributions are made locally.

At the heart of everything we do, is building strong communities.

Community Foundations are one of the fastest growing forms of philanthropy and it is encouraging to help people who want to 'give where they live'.

Entity Structure

The Top of the South Community Foundation Board of Trustees (all voluntary positions) comprises up to ten Trustees, of whom:

- One shall be appointed by the Nelson branch of the New Zealand Law Society.
- One shall be appointed by local Iwi.
- One shall be a member of the Marlborough Nelson Branch of Chartered Accountants Australia New Zealand (CAANZ).

The remainder, including any positions not filled as above, are appointed by the other Board Trustees. Certain tasks are allocated to Board Committees, but ultimately the Board is responsible.

The operational activity of the Foundation is undertaken by Top of the South Community Foundation Limited, a registered charitable entity 100% owned by Top of the South Community Foundation.

Main Sources of Entity's Cash and Resources

The main source of revenue is donations from local residents and other organisations supporting the Nelson, Tasman and Marlborough communities.

The focus is to grow endowment fund donations from local residents to support their community. Such donations are pooled and invested. The capital remains intact, and the investment income is used to make distributions annually to charities and community groups primarily in the Nelson / Tasman / Marlborough region.

When making distributions, Donor wishes are paramount -: they can choose which groups to support, or leave the decision to our Trustees who decide each year where the distributions are best directed.

Donors may:

- Leave a gift in their will.
- Donate during their lifetime and have the pleasure of seeing their money make a difference.

Endowment fund donors are invited to make an establishment donation supporting the operating expenses of the Foundation, and some donors choose to support the Foundation's operations for which we are very grateful.



The other main source of revenue is from investments.

Main Methods Used by Entity to Raise Funds

Other than endowment donations, the main source of funds is donations and sponsorship funding from private and business supporters.

The Foundation arranges the distribution of net annual income generated by the endowment fund. Donors agree to the Foundation receiving an annual contribution (currently 1% pa) from investment revenue towards the operational costs of the Foundation.

In some instances, the Foundation fulfils a Funding Manager role distributing funds on behalf of the donor, for which it receives a donation to support the costs of providing that service.

Entity's Reliance on Volunteers and Donated Goods or Services

Trustees are all volunteers. From time to time the Foundation is offered donated or discounted services to assist with running the operation; such services include accountancy, legal services, audit services, website development, investment management and marketing.

Statement of Accounting Policies

Top of the South Community Foundation For the year ended 31 March 2021

Reporting Entity

Top of the South Community Foundation is governed by a trust deed dated 30 June 2008 and by the Charities Act 2005

Basis of Preparation

The entity prepared Special Purpose Financial Statements. These are prepared based on PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Income Tax

Top of the South Community Foundation is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Tier 2 PBE Accounting Standards Applied

The board has not adopted any Tier 2 PBE Accounting Standards.

Changes in Accounting Policies

The Investment accounting policy has changed in the 2021 financial year. Previously investments were recorded at cost. They are now recorded at market value. There have been no other changes in accounting policies. All other policies have been applied on a consistent basis with those of the previous reporting period.

Investments

Investments are recorded at market value.

Grants Made

Grants made are recognised in operating expenses when distributed, subject to subsequent accountability reporting. If accountabilities are not met and the grant is recoverable by the Foundation, it is recorded in the financial statements as an assets until accountabilities are met.



Revenue Recognition

Revenue is measured at the fair value of the consideration received or receivable for the sale of goods and services, excluding goods and services tax rebates and discounts, to the extent it is probable that the economic benefits will flow to the entity and revenue can be reliably measured.

- Interest received is recognised as interest accrues, gross of refundable tax credits received.
- Dividends received are recognised on receipt, net of non-refundable tax credits.
- Donations are recorded as income on receipt.
- Grants with "use-or-return" conditions are initially reported as income in advance and subsequently reported as revenue when the conditions are met.
